Do This	Not This
Mention FM roads by number (FM 308, FM 2837)	Generic "roads"
Reference your precinct	Just "the county"
Cite county budget impacts	Only talk about city taxes
Mention rural emergency response	City-only services
Discuss groundwater and wells	City water supply only

RE: Precinct 3 Resident Opposes Data Center – County Road Impact Concerns

Dear Judge Felton and County Commissioners:

I am writing as a resident and landowner in Precinct 3 of McLennan County to express my opposition to the proposed InfraKey data center development. As a fourth-generation farmer whose family has worked this land since 1923, I am deeply concerned about the impact on county infrastructure and rural resources.

This issue directly affects McLennan County because the 520-acre facility will generate

massive truck traffic on Farm-to-Market Road 308, which the county maintains. The developer's traffic study estimates 200+ daily truck trips during construction and 50+ daily trips during operation. FM 308 was not designed for this industrial load and will require expensive county-funded repairs and upgrades.

According to the Texas Department of Transportation, heavy industrial traffic reduces rural road lifespans by 40-60%. In Williamson County, a similar data center development required \$4.2 million in county road improvements, paid entirely by county taxpayers. The county's financial responsibility for road maintenance makes this a critical concern for all McLennan County residents.

The Commissioners Court has a duty to protect county resources and taxpayer interests. This development will affect county roads, groundwater, and emergency services for decades. We need assurance that these impacts will be adequately addressed before any county permits or road use agreements are approved.

I respectfully request that the Commissioners Court:

1. Require a comprehensive county road impact study before issuing any permits
2. Ensure the developer funds all road improvements and ongoing maintenance
3. Hold a public hearing in Precinct 3 with 30 days notice
4. Coordinate with the Central Texas Groundwater Conservation District on water impacts
5. Require the developer to post a bond for future road damage repairs

Roads	FM road damage, traffic impact, maintenance costs
Water	Groundwater, rural water districts, well impacts
Emergency Services	Sheriff response times, rural EMS, fire districts
Property Rights	Ag exemptions, subdivision regulations, nuisance ordinances
Budget	Tax rates, county expenses, infrastructure funding
Flood Control	Drainage, county flood plains

Maximize Your Impact

Before Sending

- Know your precinct number
- Reference specific county roads (FM or CR numbers)

- Cite county budget/tax implications
- Mention rural/agricultural impacts if applicable
- Reference comparable county examples
- Include contact for your precinct commissioner in CC
- Proofread carefully

After Sending

- Call to confirm receipt
- Attend Commissioners Court meeting
- Follow up if no response in 2 weeks
- Share template with neighbors in your precinct
- Track commissioner voting records
