## What Your State Rep Can Do

Action	Impact
<b>Introduce Legislation</b>	File House bills for committee consideration
<b>Committee Work</b>	Serve on committees (Natural Resources, Environmental Regulation, etc.)
<b>State Budget</b>	Vote on appropriations and funding priorities
<b>Agency Oversight</b>	Oversee TCEQ, TWDB, PUC, Railroad Commission
<b>Connect Resources</b>	Link you with appropriate state agencies
<b>Advocate</b>	Champion issues within the Legislature
<b>Provide Information</b>	Explain existing state laws and regulations

## Issues Appropriate for State Representatives

Category	Examples
<b>Water Rights</b>	Usage regulations, conservation requirements
<b>Environmental</b>	TCEQ regulations and enforcement
<b>Property Rights</b>	Eminent domain, land use protections
<b>Utilities</b>	Electricity, water, gas regulations
<b>Tax Policy</b>	State tax incentives and programs
<b>Economic Development</b>	State incentive programs
<b>State Agencies</b>	Oversight and accountability
<b>Infrastructure</b>	State funding for roads, water systems
<b>Public Health</b>	Safety standards and regulations

<b>Special Session</b>	As called by Governor	30 days	Limited topics only

<b>Before Regular Session</b>	Contact about new legislation	Bills must be filed early
<b>Early Session</b>	Press for committee hearings	Bills move through committees first
<b>Interim Period</b>	Request agency oversight	Good time for studies and relationships
<b>Any Time</b>	Constituent services	Representatives help year-round

**RE: Request for State Legislation on Industrial Water Impact Assessments**

Dear Representative Curry:

I am writing as your constituent in Waco to request your assistance in addressing industrial water usage across Texas. As a homeowner and registered voter in District 56, I am concerned that current state law does not adequately protect community water resources from large-scale industrial developments, and believe state legislation is necessary to ensure proper environmental oversight.

This issue affects not only our local community but communities across Texas. According to the Houston Advanced Research Center, Texas data centers will consume 399 billion gallons of water annually by 2030 - representing 6.6% of the state's total water supply.

Our situation in Waco, where a proposed 520-acre data center would use 4.5 million gallons daily while residents face water restrictions, is an example of a larger trend that requires state-level action.

While local officials are doing what they can, current state law limits local authority to regulate industrial water use. The Texas Water Code does not require comprehensive water impact assessments for industrial facilities, leaving communities vulnerable to resource depletion. Texas needs mandatory environmental impact requirements for large industrial water users to ensure that communities can protect their essential resources.

Other states have addressed similar issues through state-level legislation. Virginia enacted HB 1989 requiring water impact assessments for data centers over 25 megawatts, resulting in better community planning and resource protection. Arizona requires groundwater impact studies for facilities using over 250,000 gallons daily. Texas should consider similar approaches to protect our water resources and give communities a voice in major development decisions.

I respectfully request that you:

1. Introduce legislation requiring water impact assessments for industrial facilities using over 1 million gallons daily
2. Request a hearing by the House Committee on Natural Resources on data center water usage in Texas
3. Work with TCEQ to develop updated regulations for large industrial water users
4. Consider meeting with District 56 constituents to discuss water resource protection

## Submission Tips

### Best Practices

Tip	Details
<b>Include Address</b>	Full address proves you're a constituent
<b>Voter Status</b>	Mention you're a registered voter
<b>Be Specific</b>	State exactly what legislative action you want
<b>Cite Examples</b>	Reference other states' approaches
<b>Session Timing</b>	Send during legislative session for maximum impact
<b>Follow Up</b>	Contact staff if no response in 2 weeks
<b>Office Hours</b>	Consider visiting during constituent office hours
<b>Offer to Testify</b>	If legislation is filed, offer to testify

## Email Version

### Format Adjustments:

- Same structure, but shorter (2-3 paragraphs)
- Clear subject line: "[District #] Constituent Requests [Action]"
- Include contact info in signature
- Attach supporting documents if relevant

## State Representative vs. State Senator

### Key Differences

Factor	State Representative	State Senator
Term Length	2 years	4 years
Number	150 members	31 members
Influence	Specialized knowledge	More institutional power
Bills	Often originate here	Review and amend House bills
Focus	More local/specific	Broader, statewide
Elections	More frequent	Less frequent

**Strategy:** Contact both on major issues, but emphasize statewide significance with senators.

## Maximize Your Impact

### Before Sending

- [ ] Confirmed you're in District 56 (or found your actual district)
- [ ] Researched representative's committee assignments
- [ ] Included specific legislative request
- [ ] Cited examples from other states
- [ ] Mentioned you're a voter

- Proofread carefully
- Timed for legislative session if possible

## After Sending

- Called office to confirm receipt
- Asked about representative's position on issue
- Offered to provide more information
- Tracked any bills filed on topic
- Thanked representative for supportive actions
- Coordinated with other constituents
